Mr. Ashok Verghese stated that the admission for the academic year 2021-22 for CODE programs has commenced and the Management announced 75% scholarship, as launch offer, for those who join this year.

The Vice Chancellor extended his hearty welcome to all the members. In his address, he requested all the members to share their valuable advice on the agenda items related to academic and infrastructure.

3. Confirmation of the Minutes of the 12th Meeting of the Planning and Monitoring Board held on 16th February 2021.

Dr. V.N. Rajasekharan Pillai and Dr. Xavier Alphonse pointed out that if any new program is introduced by the University, the same should be informed to the UGC, along with the recommendations of the Academic Council. The UGC will consider this matter and approve the nomenclature of the new programs along with the duration of each program. This will help the students to graduate with new degrees after the completion of the program.

4. Action Taken Report on the 12th Meeting of the Planning and Monitoring Board held on 16th February 2021.

Rev. Fr. Dr. Xavier Alphonse suggested to discontinue programs with less student strength and introduce new and innovative programs to attract more number of students. Similarly, the conventional programs such as Economics, B.Com. etc. may be dropped and in their places new programs, suitable to the present scenario, can be introduced, because the Deemed Universities have such flexibility.

He also stated that there should be a Screening Committee to check these issues before the research paper is sent for publication.

The Vice Chancellor informed that HITS encourages publications in journals which are indexed in **Scopus** / **WOS** and hence the quality of the journal is guaranteed.

Rev. Fr. Dr. Xavier Alphonse pointed out that the administration of HITS should see if all the MOUs are active and contents are implemented.

Mr. Ashok Verghese, Director informed to remove the inactive MOUs as suggested by the expert members and to initiate activities with active partner universities. He added that activities with partner universities to be improved. Fellowship for Faculty of Partner Universities to join Ph.D. to be introduced. Adjunct Faculty are to be identified in specific emerging areas for appointment in HITS.

- Company specific training programmes were conducted for students to prepare them for placements.
- Partnership with 20 + core companies during 2020-21 for recruitments.
- Students were motivated to actively participate in recruitment drives.

B. PLAN FOR 2021-22 & subsequent batches

The Placement Department has planned to invite **200** companies across India for recruitment during the year 2021-2022.

(1) Soft skills training for students:

(a) 30 hrs per student in a year

(2) Pre placement training:

- (a) 20 days during summer after the 6th semester
- (b) Feedback score for the program should be more than 80% and attendance at 90%

(3) Revenue generation through Corporate Partnerships, Training and Consultancy: Rs. 1.00 Crore

91% of the final year students will be placed in the industries during 2021-22

Note: Focus to be given on core company placements

Further, in order to improve the placements, the following strategies will be implemented:

- Organizing corporate, connect series, HR-talk series and guest lectures by industry experts from Tier 1 companies to encourage and prepare the students for placement.
- Improving the number of placements in dream / super dream / core companies by introducing diagnostic assessments (AMCAT) from 2nd year to final year.
- Organizing training programs based on the assessment reports to increase the placement percentage considerably.
- Partnering with new organizations and improve campus recruitment.

- Initiating incremental training from first year onwards and intensive training programs for current third/final years
- Involving more alumni to increase placement opportunities for the students.

Members pointed out that the percentage of calculation of number of students placed shall be based upon the number of eligible students and not based on the number of students opted for placement. The data indicate that only 50-60% of eligible students are being placed every year through Placement Department. The placement of the students should be increased significantly to 90% of the eligible students. The Placement Department was advised meticulously plan to achieve the target for 2021-22.

He said that in order to improve Research Climate among faculty members, HITS should adopt the following ways: (i) Awareness and Education; (ii) Enhancement of incentives to the faculty and (iii) invite International Researchers to our campus for interaction with our faculty members.

The Registrar informed that HITS has appointed a Dean for Research initiatives in order to improve the research quality among faculty members.

20. Presentation by the Vice Chancellor:

The Vice Chancellor presented a PPT on Hindustan Performance Management to the board members. The presentation highlighted the targets fixed for every department for 2021-22.

The target is assigned to the respective HODs and also to the faculty of the departments.

The periodic analysis will be carried out meticulously so that the staffs and faculties of the departments can improve their performance to achieve the target.

If a department has achieved the target, then a huge amount of incentive is granted to the department which can be shared among everyone in the department. Likewise, for each responsible position, the key performance indices are identified for fixing the targets.

The objective of the HPM is to entertain / to create awareness in a person to aware about his roles and responsibilities at HITS.

Rev. Fr. Dr. Xavier Alphonse appreciated the proposal and implementation of "Hindustan Performance Management" in which all the Officers, from the Vice Chancellor, Pro Vice Chancellor, to the faculty members will aware of their responsibilities. Further Dr. Xavier Alphonse suggested that the performance could be reviewed periodically (every 3 month) so as to check the progress made every individual staff.

Feedback of the Members

Dr. Rajasekharan Pillai thanked HITS for inviting him for the meeting of the Planning and Monitoring Board. He further suggested that HITS should have develop image like specialty in specific domains in emerging areas. He said that a brand name is very important just like foreign universities, where one particular area is focused and advertised. HITS can seek the help from Professional Advertising Agencies for this purpose.

The Vice Chancellor stated that HITS has an action plan. He further said that the Management of HITS is looking for launching KCG Satellite at a cost of 1.50 Crores and they are looking for a Company which is technically equipped for the same. HITS is planning to involve students and faculty members in the development of the Satellite.

Dr. Xavier Alphonse said that he is honored to be a part of the Planning and Monitoring Board of HITS.
