- Dr. Rajeev Ahuja, enquired about the new programme proposed in the previous BOM
  meeting ie. M.Sc. Nano Science and Technology. He insisted to include Quantum
  Technology in the nomenclature, as this emerging technology has great scope in the
  future.
- The Pro Chancellor, Vice Chancellor and Pro Vice Chancellor explained the difficulties
  of getting experts in the field of Quantum Technology. Hence, Dr. Rajeev assured to
  extend the support in identifying the experts for framing the curriculum and syllabus and
  to be the members of BOS meetings.
- Dr. Rajeev also informed that few of the IITs have introduced M.Tech programme with specialization in Engineering Education to cater the need of expertise in Engineering Education.
- The Executive Director suggested to introduce Non-CGPA courses on Engineering

Education and also to introduce many multi-disciplinary programmes in line with the

NEP.

• The Vice Chancellor informed that as per the directions of Founder Chancellor and

Chancellor, coaching classes have been planned for skill development and placements.

The Pro Vice Chancellor added that already Hindustan Professional Coaching Academy

has been initiated and around 500 students attended the awareness program organized by

the academy.
